## **Network Wales** Awards launch with new category

You'll have the chance to hear directly from funders, garner funding advice straight from the experts and learn the secrets of fundraising success. There will also be some inspirational plenary speakers, a huge range of workshops and a bustling exhibition area – perfect for networking.

The morning has a plenary session from Jane Hutt, AM, and following this, Joe Saxton of nfp Synergy will speak about how charities can stay competitive in a turbulent world.

Afternoon highlights include Derek Walker from the Big Lottery Fund and Liz Lipscomb of the Charities Aid Foundation. Also, Mervi Slade of Charitable Giving will explain how your group can make the most of payroll giving.

## WCVA responds to consultation and says 'no' to any reduction in lottery funding in Wales

WCVA has said that it does not support any change that reduces the overall share of Lottery funding received by the four distributors to spend in Wales, or reduces the overall funding for the third sector.

WCVA has responded to the Department for Culture, Media, and Sport (DCMS) consultation on its proposals to reduce the allocation to the Big Lottery Fund (BIG) from 50% to 40%, and to reallocate this to the sport, arts and heritage Lottery distributors.

Unlike the other distributors, BIG's share for Wales takes account of social need. If funds are moved from BIG to the other distributors without an adjustment for social need, Wales could lose out by between £5m and £6m. In its response WCVA has sought assurances that overall Lottery funding in Wales is not cut as a result of any change.

The response also seeks assurances that there is no reduction in funding for the third sector. It highlights that BIG is the main third sector funder for the third sector, and any reduction in its allocation will be a matter of concern to a very wide range of organisations.

BIG is also charged with promoting community cohesion, and any reduction is likely to have an adverse effect on organisations working to promote equality and advance social justice. The response argues that if the government does transfer funds from BIG to the other distributors, they should be required to use at least the amounts transferred exclusively for community-led third sector projects.

In a related development, DCMS has announced a further consultation on a change to policy direction for the BIG Lottery Fund aimed at a change in direction to focus future funding streams on projects that assist people and local communities served by the third sector.

The expectation is that BIG would continue to fund the same types of projects, but that there should be a specific focus of their funding on the third sector. We will soon be putting the options related to these proposals to the sector.
